ORDINANCE 2024-2

AN ORDINANCE OF THE BOROUGH OF PEMBERTON AMENDING PORTIONS OF CHAPTER 205 ENTITLED "WATER AND SEWER SERVICES" OF THE CODE OF THE BOROUGH OF PEMBERTON

BE IT ORDAINED by the Borough Council of the Borough of Pemberton, County of Burlington as follows:

Section 1. Code § 205-27.A.(1) is hereby amended as follows:

- A. Minimum quarterly charges (metered) for water service
 - (1) Single-family residential users. The minimum quarterly charge for all one-family residential dwellings is \$70.00 per quarter based on a quarterly allowance of 10,000 gallons.

Section 2. Code § 205-27.A.(3)(a) is hereby amended as follows:

- (3) Single commercial and industrial users. All other classes of single users will be subject to the following minimum quarterly charges:
 - (a) Metered Service
 - [1] Ouarterly minimum water charge: \$70.00 per unit.
 - [2] Water allowance for minimum charge (gallons): 10,000.

Section 3. Code § 205-30. Schedule W. Water service between the Borough of Pemberton and Pemberton Township.

The terms for the provision of water service from the Borough of Pemberton to single family residential users is set forth in the December 1, 2021 shared service agreement, which shall remain in effect until March 31, 2031.

Section 4. Code \S 205-32A. (1) and (2) are hereby amended as follows:

(2) Other uses.

- (a) Self-service laundries, restaurants, diners, schools, taverns, bars, nursing homes, bowling alleys, theaters, shopping centers, large business establishments and plants and other commercial establishments not specifically mentioned shall be based on the quantity of all waste having characteristics of those of domestic sewage as follows: per 300 gallons per day of fraction thereof or 27,000 gallons per quarter (300 gallons per day, 30 days per month), the amount normally computed as the discharge of sewage from a single family, exclusive of infiltration: \$544 per unit.
- (b) Industrial wastes based on quantity and concentration of sewage other than that of domestic sewage charges shall be established on the basis of cost to the Borough of the particular treatment process and industry.

The within Ordinance shall take effect immediately upon final passage and publication as required by law.
