

**BOROUGH OF PEMBERTON**  
**ORDINANCE 2025-2**

**AN ORDINANCE OF THE BOROUGH OF PEMBERTON RELATING TO THE SALARIES, WAGES, OR  
OTHER COMPENSATION OF ALL OFFICERS, APPOINTEES, AND OTHER EMPLOYEES OF THE  
BOROUGH OF PEMBERTON**

**BE IT ORDAINED** by the Borough Council of the Borough of Pemberton, in the County of Burlington and State of New Jersey as follows:

**SECTION 1:** Salaries for the following positions **shall not exceed** the amount set forth for each position, with the annual salary to be established annually by resolution of the Borough Council:

**Mayor** – Ten Thousand Dollars (\$10,000.00)

**Councilman/woman** – Four Thousand Dollars (\$4,000.00)

**Administrator** – One Hundred Ten Thousand Dollars (\$110,000.00)

**Municipal Clerk** – One Hundred Ten Thousand Dollars (\$110,000.00)

**Deputy Clerk** – Seventy Thousand Dollars (\$70,000.00)

**Administrative Assistant** – Sixty Thousand Dollars (\$60,000.00)

**Treasurer** – Ten Thousand Dollars (\$10,000.00)

**Assistant Treasurer** – Five Thousand Dollars (\$5,000.00)

**Planning/Zoning Board Secretary** – Eight Thousand Dollars (\$8,000.00)

**Tax Collector** – Fifteen Thousand Dollars (\$15,000.00)

**Tax Search Officer** – One Thousand Dollars (\$1,000.00)

**Tax Assessor** – Fifteen Thousand Dollars (\$15,000.00)

**Chief Financial Officer** – Ten Thousand Dollars (\$10,000.00)

**Qualified Purchasing Agent** – Seven Thousand Dollars (\$7,000.00)

**Construction/Electrical Inspector** – Fifteen Thousand Dollars (\$15,000.00)

**TACO** – Seven Thousand Dollars (\$7,000.00)

**Public Works Coordinator** – Ninety Thousand Dollars (\$90,000.00)

**Assistant Public Works Coordinator** – Seventy Thousand Dollars (\$70,000.00)

**Code Enforcement Officer** – Fifteen Thousand Dollars (\$15,000.00)

**Code Enforcement Secretary** – Five Thousand Dollars (\$5,000.00)

**Chief of Police** – One Hundred Twenty-Five Thousand Dollars (\$125,000.00)

**Municipal Court Administrator** – Sixty Thousand Dollars (\$60,000.00)

**Certified Recycling Professional** – Five Thousand Dollars (\$5,000.00)

**Recycling Coordinator** - Five Thousand Dollars (\$5,000.00)

**Licensed Water/Sewer Official** – Fifteen Thousand Dollars (\$15,000.00)

**Water / Sewer Foreman** – Ten Thousand Dollars (\$10,000.00)

**Fire Inspector** – Six Thousand Dollars (\$6,000.00)

**Plumbing Inspector** – Six Thousand Dollars (\$6,000.00)

**Section 2:** The hourly rate for the following positions **shall not exceed** the amount set forth for each position, with the hourly rate to be paid established annually by resolution of the Borough Council:

**Line Workers** – Seventy Dollars (\$70.00)

**Electric Foreman** – Ninety Dollars (\$90.00)

**Part-time Utilities Laborer** – Twenty Dollars (\$20.00)

**Police Secretary** – Twenty Dollars (\$20.00)

**Part-time Patrolman** – Twenty-Five Dollars (\$25.00)

**Executive Police Administrator** – Thirty Dollars (\$30.00)

**Special Officer** – Twenty Dollars (\$20.00)

**Deputy Court Administrator** – Thirty Dollars (\$30.00)

**Temporary Clerical Help** – Twenty Dollars (\$20.00)

**Section 3:** The rate per court session for the following positions **shall not exceed** the amount set forth for each position, with the rate to be paid established annually by resolution of the Borough Council:

**Municipal Court Judge** – Eight Hundred Dollars (\$800.00)

**Municipal Court Prosecutor** – Five Hundred Dollars (\$500.00)

**Court Clerk** – One Hundred Dollars (\$100.00)

**Recording Supervisor** – One Hundred Dollars (\$100.00)

**Deputy Court Administrator** – One Hundred Dollars (\$100.00)

**Section 4:** The rate per call out for the following positions **shall not exceed** the amount set forth for each position, with the rate to be paid established annually by resolution of the Borough Council:

**Court Clerk** – Thirty Dollars (\$30.00)

**Lineman** – One Hundred Ninety Dollars (\$190.00) for the first 2 ½ hours

**Section 5:** The following positions shall be appointed without salary.

**Electric Utility Clerk** – No Salary

**Water/Sewer Utility Clerk** – No Salary

**Municipal Search Officer** – No Salary

**Section 6:** The salary and wages shall be fixed annually by resolution and may be retroactive to January 1<sup>st</sup> of each year.
